- 電視機：其顯示屏幕的尺寸不超過 100 吋(以對角斜角量度)。  
電腦：包括個人電腦、桌上電腦、平板電腦、手提電腦及筆記簿電腦。  
列印機：其重量不超過 30 公斤；如同時用作影印機、圖文傳真機或掃描器，仍視作列印機。  
掃描器：其重量不超過 30 公斤。  
顯示器：不具備儲存電子數據或運算的功能；其顯示屏幕的尺寸為 5.5 吋至 100 吋內(以對角斜角量度)。

| 5) | Remarks                       | (a) The removal service may not take place at the same time as delivery and installation. The old items pending removal can be removed in advance or placed temporarily at the premises for collection later as appropriate. Customers can contact us for appropriate arrangement.<br>(b) The old items will not be returned once collected.<br>(c) The old items must be stand-alone ready for removal and be freed from other connections or obstacles.<br>(d) If the old items have serious hygiene issues (e.g. food residues, presence of cockroaches and ants, etc.), our staff will have the right to refuse to remove such items, and no free removal service for the customers will subsequently be arranged.<br>(e) Customers shall give no less than 2 working days' notice in respect of any request for change of delivery time, date and/or place for the removal service.<br>(f) In the event of a Black Rainstorm Warning / Tropical Cyclone Warning Signal No. 8 or above, the removal service will be suspended and rescheduled.<br>(g) The company shall not be liable for any delay, suspension or rescheduling of the removal service due to traffic or adverse weather conditions or any other factors.<br>(h) All personal data are for the purpose of arranging removal service only and the company shall comply fully with the obligations and requirements under the Personal Data (Privacy) Ordinance (Cap. 486).<br>(i) In case of any disputes, the decision of the company shall be final. |

| Monitors    | - not having the function of storing electronic data or computing, the size of the display screen is not smaller than 5.5 inches (measured diagonally) but not exceeding 100 inches (measured diagonally). |
